# Meeting of the Committee on Organic Production 7 March 2017

Chairman: Lene NAESAGER

27 Member States were present. 1 MS was absent. Norway and Switzerland were present as observers

# **Section A – Opinion of the Committee**

1. Commission Implementing Regulation (EU) amending Regulation (EC) No 889/2008 as regards feed for certain organic aquaculture animals

The Committee voted in favour of an Implementing Regulation amending Regulation (EC) No 889/2008 as regards feed for certain organic aquaculture animals. The purpose of the modification is to ensure that the dietary needs of these animals – primarily carp, shrimp and tropical fish such as pangasius – can be met during their early life stages in hatcheries and nurseries.

# **5.** Miscellaneous<sup>1</sup>

Cooperation between DG AGRI and Accreditation Bodies

The Commission reminded that the Action Plan on Organic production defines cooperation with the Accreditation bodies as a major priority. Therefore the Commission tries to encourage Member States to explore synergies and simplifications between activities by Accreditation Bodies and Competent Authorities. The Commission also liaises with Accreditation Bodies responsible for the surveillance on Control Bodies in Third Countries.

Official controls and organics

A presentation of the main issues covered in the new Official Controls Regulation was made.

• Production of organic rice in the EU – follow-up

An exchange of views took place following information submitted from the delegations.

• End of derogation on 5% of non-organic protein animal feed and derogation on the use of non-organic pullets less than 18 weeks.

Those derogations are due to expire at the end of 2017. Exchange of view with delegations

• Authorisation of non-organic ingredients

A presentation was made on the trends and legal framework and an exchange of views took place concerning the authorisations to use non-organic ingredients of agricultural origin to operators.

- Conclusions of the BTSF workshop (Grange, Ireland 27-29 September 2016) on how to improve controls
- Overview of imports

The Commission presented a draft study on first analysis of data related to imports of organic products drafted by Marie Herman (trainee).

• Update on the incorporation of the EU Organic Regulations to the EEA Agreement

Any subjects that the Member States wish to discuss under Point 'Miscellaneous' need to be submitted to the Commission and the other Member States at the latest one week before the meeting of the Committee on Organic Production.

The Commission debriefed MS about the upcoming incorporation of the EU Organic Regulations to the EEA Agreement.
