Short Report of the 135th meeting of the Committee on Organic Production of 29 November 2016

27 Member States were present. 1 MS was absent. Norway, Switzerland and Iceland were present as observers.

Section A – Opinion of the Committee

1. Draft Commission Implementing Regulation (EU) amending Regulation (EC) No 1235/2008 laying down detailed rules for implementation of Council Regulation (EC) No 834/2007 as regards the arrangements for imports of organic products from third countries (amendment of annexes III and IV).

The Commission presented the document in its final form. The Committee gave a favourable opinion on the draft Regulation (26 MS voted in favour, 1 MS abstained, 1 MS was not represented).

With regard to Chile, the Commission informed about state of play of proposals for Council decisions authorising signature and conclusion of the agreement.

b. Debriefing on plurilateral arrangement meeting in Bern

The Commission debriefed the Committee about an expert workshop held in Bern (CH) on 2-3 November 2016 to explore a plurilateral arrangement on organics.

The Commission presented the latest news about the group. State of art the new call for application and the final report on PPPIII recently published.

6. Pesticide residues testing in organic production, presentation of conclusions by DG SANTE Directorate F

DG SANTE provided an overview of the main results of pesticide residues testing in organic production.
